



Understanding the Law of Faith: Why Many People's Faith Doesn't Work Romans 3:28, 31 & James 2:14-26

Faith is a Law which means that it is subjective, but is governed and operates upon pre-established principles to accomplish or manifest a predetermined outcome and purpose – Victory – Every time!

Kingdom's Constitution: *"Man does not live by bread alone, but by every word that proceeds out of the mouth of God."*

Kingdom's National Anthem: *"The just shall live by faith"* is the Kingdom's national anthem for its citizenship for it is the power that propels them to live supernaturally, gives them access to all the Kingdom and God has and is the currency that is utilized to receive and achieve in the Kingdom.

- **Faith is not a New Testament creation: Galatians 3:7, Habbakuk 2:4**
 - **Romans 1:17, 2Cor. 5:7, Galatians 3:11, Hebrews 10:38,**

Religiously faith has been confined to a what we choose to believe concerning our salvation, but it is designed to "SAVE" us from the consequence of our original lack of faith (Adam).

This revelation (revealing of truth) is necessary for the Believer to have dominion in the earth and over their circumstances.

Hebrews 11:1, 3, 6 – "What is faith?"

- Faith is the conduit to having both Kingdom riches and natural riches because their origin is one and the same - the Word of God.
- All things come from the Word (Gen.1, John 1:1-4, Colossians 1:13-17, Hebrews 11:1,3, Hebrews 1:3 and Romans 10:17).

Romans 10:17 – Faith is born by the command, word, law of God.

It is the consequence of the "reciprocal duty" of being a citizen in the Kingdom: (1) Allegiance, (2) Obedience, and (3) support of the Kingdom's advancement.

James 2:9 & Romans 4:17-21 – Mental assent and confession is impotent in the Kingdom.

The term "Believer" has been universally applied to all who confess to accept Jesus as their Lord and Savior. There is a great difference between what the Bible qualifies as Belief and faith, and what is held by most believers. Biblical belief is neither "intellectual" nor "sensual" – it is supernatural

Joshua 1:7-8 & Psalms 1:3 - God's Word is insight, instructions and provision for man to prosper

- it is a protection, provision and preservative of man's prosperity

Genesis 3:1-7 - Satan's only power is persuasion through the Intellect and Senses

- 1John 5:4



James 2:14-26

Faith requires a commitment to the manifestation of God's Word regardless of the objective facts to the contrary. Faith is the provision to overcome situational living.

Law of Faith and Works: is the necessary corresponding spiritual and physical cooperation required for manifestation. Faith is the "mens" and works the "rea" of an action, which makes it legally actionable. Faith is the substance of things hoped (expectation), the evidence of things not seen. Faith is evidence, hope is expectation.

- Law of Faith and Law of Works governed two distinct economies of the Kingdom's process of revelation and manifestation in the earth. The Law of Works became necessary because the Law of Faith had become violated and man, in losing the manifested Kingdom "fell" to a lesser, but necessary Kingdom until the fullness of the Primary Law of Faith could be restored as the primary economy of the Kingdom in the earth by the finished work of Christ.

Law One: All Faith is a Consequence and Fruit of God's Word.

Law Two: Faith is the pre-requisite for possession in the Kingdom.

Anything acquired as a Kingdom citizenship must be acquired by faith - or it is *illegal*. This is why acquisition by faith from God is as added "without sorrow"! It is legal. Any gain acquired in an unauthorized and illegal fashion is illegal, from the enemy and will ultimately engender loss and suffering.

Adam and Eve broke this law by trying to acquire without the utilization and exercise of faith. Jesus demonstrated this law by Satan's attempt to cause Jesus to break this law by tempting Him with acquisition without faith (food. Adam was fruit, Jesus' temptation was bread both are foods).

Law Three: Faith is the currency of the Kingdom.

It is of the highest value to God and is the means by which business is transacted in the Kingdom. Without faith it is impossible to please God. We acquire the riches of heaven by faith. It is a treasure worth more than the world's God and cannot be bought, but must be birth by revelation by and of the work of the Holy Spirit.

- Those **without money** in this world's system are considered poor. When you loose your money, in this world's system you are simply "**depleted**"!
- Those **without faith** in the Kingdom of God are considered poor. When you loose your faith, as a citizen in the Kingdom of God you are "**defeated**"! *As long as God is your Source you are never depleted, access is always available, but it will require faith to acquire what is needed!*

Therefore, Satan is not after your house, finances or job (he doesn't need nor is he threatened by these things, because he already has authority over these things (Mat. 4:6, Luke 4:6)

Satan is after your faith, because it is the power that overcomes the world and his system (1 John 5:4), and the currency that you live by (Habakkuk 2:4, Romans 1:17, Hebrews 2:38).
